

# REPORT ON THE DISASTER RELIEF FUND 2024-25

## INTRODUCTION

This report gives an account of the operation of the Disaster Relief Fund (“the Fund”) in 2024-25.

## DISASTER RELIEF FUND

2. The Fund was established on 1 December 1993 under the Public Finance Ordinance (“PFO”) to provide a ready mechanism for Hong Kong to respond swiftly to international appeals for humanitarian aid in relief of disasters that occur outside Hong Kong. The Fund is topped up by the Government of Hong Kong Special Administrative Region (“the HKSAR Government”) at the start of each financial year and, as necessary, during the financial year, depending on calls for relief and the size of the Fund balance and commitments.

3. As in the case of other funds set up under the PFO, the Financial Secretary has been designated as the administrator of the Fund. The Financial Secretary has further delegated the power of administering the Fund to the Director of Administration, including the authority to approve each individual disbursement not exceeding \$8 million. The approval of the Finance Committee of the Legislative Council (“LegCo”) is required for each individual disbursement exceeding \$8 million. The Fund is audited by the Audit Commission annually and the audited accounts are submitted to LegCo for information<sup>[1]</sup>.

4. All grants from the Fund are made on the advice of the Disaster Relief Fund Advisory Committee (“the Committee”) which is chaired by the Chief Secretary for Administration and comprises both official and non-official members. Its terms of reference include providing advice on the policy and practices regarding the disbursements of funds for disaster relief and the size of grants made to specified recipients, and monitoring the use of grants. The membership of the Committee in 2024-25 is at *Annex A*.

## WORK IN 2024-25

### Processing of Grant Applications

5. The Committee assesses funding applications in a fair and objective manner in accordance with a set of established guidelines and conditions for grants, which are set out at *Annex B*. In 2024-25, a total of 24 funding applications were received from applicant organisations, 23 of which were approved and one was withdrawn by the organisation itself. During the reporting period, grants totalling \$84.99 million were granted to nine organisations to conduct relief programmes in seven geographical regions/countries, and the estimated number of beneficiaries was around 540 000. The relief programmes covered extensive regions. Apart from the Chinese Mainland and other Asia-Pacific regions (including Nepal, Bangladesh, Myanmar and Vietnam), the programmes also reached as far as Kenya in Africa and Brazil in Latin America. It was for the first time since the establishment of the Fund in 1993 that Brazil was covered by a relief programme supported by the Fund.

6. Among the nine organisations which successfully applied for funding in 2024-25, World Vision Hong Kong had six programmes approved with a total grant amount of \$19.428 million, making it the organisation with both the largest number of approved programmes and the highest total grant amount. A list of programmes with approved grants, related photographs and statistics are set out at *Annex C*. The average processing time for the 23 applications was 7.5 working days, all earlier than the target of 12 working days (i.e. from the date of receipt of full information from the applicant to the date of notification of result).

### Monitoring the Use of Grants

7. The Committee continued to adopt the following measures to monitor the use of grants:

- (a) the applicant organisation is required to lay down a relief schedule setting out, among other things, the commencement and completion dates of a programme, and report to the Secretariat of the Committee (“the Secretariat”) the critical programme milestones within one month from the respective scheduled dates;

- (b) if the applicant organisation has made specific minor variations to an approved relief programme with its delegated authority<sup>[2]</sup>, it is required to notify the Committee within one month from the effective date of the variations;
- (c) save for the minor variations mentioned in (b) above, should there be signs of deviation from the approved targets (such as the schedule, relief location and types of relief items) of a programme, the applicant organisation is required to obtain prior approval from the Committee;
- (d) the applicant organisation is required to obtain at least three quotations in each procurement exercise to ensure proper use of funding for procuring relief items and the procedures should be conducted in a fair and open manner;
- (e) overheads or other administrative costs of the relief programme borne by the applicant organisation should not exceed 5% of the grant or 5% of the total expenditure, whichever is less. Such expenditures should not be used to support the daily operation of the organisation;
- (f) the applicant organisation is required to display prominently the message that the relief items are “Funded by the Government of the Hong Kong Special Administrative Region” or “Funded by the Disaster Relief Fund, Government of the Hong Kong Special Administrative Region”, and provide photographs in the evaluation report as proof of compliance with this requirement;
- (g) the applicant organisation is required to submit an evaluation report and an audited account within six months upon completion of the relief programme. The evaluation report submitted should give an overall assessment of the programme targets (including the number of beneficiaries and the time needed for delivery of emergency relief). The evaluation report and audited account are examined by the Secretariat before they are submitted to the Committee for information. The Audit Commission will also inspect the evaluation report and the audited account during the annual audit exercise to

Any increase in the number of beneficiaries and quantities of relief items should not exceed 20% of their original targets. The level of change for the budget of individual spending items will not be capped.

ensure that the relief programme is conducted according to the funding requirements;

- (h) the applicant organisation is required to provide information in the application to confirm that it has established a code of conduct, disciplinary procedures, recruitment vetting and reporting system to guard against and handle staff misconduct cases properly. In the event of any incident detrimental to the beneficiaries and the Fund, such as sexual harassment or exploitation, abuse, fraud and improper use of the grant, the organisation shall, within two weeks upon such incident coming to its knowledge, provide a brief report to the Secretariat on, inter alia, the nature of the incident and actions taken; and
- (i) if an applicant organisation commits a serious violation of grant conditions, it must submit a concrete improvement proposal (e.g. review the organisation's implementation procedures and monitoring measures of the relief programme) in addition to providing an explanation of the circumstances. The Secretariat will make recommendations according to individual circumstances for the Committee to consider whether further action is required. When processing the applicant organisation's future funding applications, the Secretariat will make recommendations for the Committee's consideration based on the organisation's non-compliance record in the past three financial years.

8. To promote public understanding of and confidence in the monitoring of the use of grants under the Fund, the Committee has uploaded the prevailing monitoring measures and frequently asked questions onto the Fund's website to enhance the transparency of the mechanism and facilitate public access to the relevant information.

## Processing Applications for Programme Variations

9. In 2024-25, the Committee received a total of 21 applications for programme variations, comprising three major and 18 minor variations<sup>[3]</sup>. Of these applications, 12 (for both major and minor variations) were processed within the respective target timelines. The processing time for major variation applications was seven working days, earlier than the target of eight working days; while the average processing time for minor variation applications was two working days, earlier than the target of three working days. The remaining nine applications were retrospective applications for programme variations. Since the variations would not affect the designated purposes of the grants and were due to reasonable causes, the Committee approved all of them after examining the applications in accordance with the prevailing procedures. Meanwhile, all the 17 notifications of minor variation cases handled by the organisations under delegated authority fulfilled the requirement of not exceeding the 20% variation limit.

## Evaluation Reports and Audited Accounts from Grant Recipients

10. The Secretariat received and reviewed nine and 22 sets of evaluation reports and audited accounts (a total of 31 sets) submitted by the applicant organisations in 2023-24 and 2024-25<sup>[4]</sup> respectively in respect of the completed programmes and circulated them to the Committee. The reviewed reports were accepted for having met the prescribed targets<sup>[5]</sup> as follows:

- (a) use of grants — all grants were used for the approved purposes and in compliance with the condition that not more than 5% of an individual grant or total expenditure (whichever is less) should be used to cover overheads or other administrative costs. Among the 31 relief programmes reviewed, 24 recorded a balance of unused grants

totalling about \$6.339 million (accounting for 6.3% of the total grants for the programmes) which were refunded to the Fund;

- (b) number of beneficiaries — all the 31 reviewed relief programmes have met their targets, providing emergency assistance to approximately 800 000 victims in aggregate (including those affected by flooding, typhoons/cyclones and earthquakes in Afghanistan, Chinese Mainland, India, Indonesia, Malawi, Myanmar, Nepal, Syria, the Philippines and Türkiye). Relief items distributed to the beneficiaries under these programmes included food (such as drinking water, rice, dried fish, soya-bean chunks, tea, coffee, canned food, corn flour, flour, noodles, cooking oil, beans and seasonings), blankets/ quilts/ down quilts/ fleece quilts, floor mats, mosquito nets, kitchenware, lighting tools, water purification tablets, hygiene items, household items, clothing, temporary shelter materials and tools, psychosocial support kits, children psychosocial support kits, learning material kits, education kits, as well as temporary latrines; and
- (c) timely completion of the programmes — all the relief programmes were delivered according to the approved schedules<sup>[6]</sup>.

The annual audit of the Fund conducted by the Audit Commission included examining the accounts and operation of the Fund as well as the evaluation reports submitted by applicant organisations. Upon completion of the annual audit, the Audit Commission submitted an independent auditor's report on the Fund's accounts to LegCo to certify that the Audit Commission had examined and audited the financial statements of the Fund and in its opinion, the financial statements of the Fund had been prepared, in all material respects, in accordance with the PFO (Cap.2) and section 11(1) of the Audit Ordinance (Cap. 122).

### **Improvement Measures to Facilitate Applicant Organisations**

11. In 2024-25, the Committee has reviewed the application procedures for grants under the Fund and agreed that the Secretariat should devise an unified and standard application form to streamline the procedures, thereby facilitating the submission of applications by organisations in a more efficient manner. Applicant organisations can provide the necessary information in a standardised manner through the application form without the need to prepare lengthy

proposals. Apart from facilitating applicant organisations, the arrangement also enables the Secretariat to review the information provided in application form more efficiently, thereby speeding up the processing of grant applications. The new measure was implemented on 1 December 2024. Meanwhile, the Secretariat has also updated the Guide to Grant Application, setting out in detail the matters that the applicant organisations need to pay special attention to when submitting the applications, thereby facilitating the application process.

## **OVERVIEW OF GRANTS APPROVED IN THE PAST FIVE YEARS**

12. The Committee received a cumulative total of 110 applications by applicant organisations for grants from the Fund from 2020-21 to 2024-25. Of this total, 106 (i.e. 96.36%) applications for grants amounting to \$389.219 million, involving 20 organisations, were approved. The remaining four applications were withdrawn by the organisations themselves. For the above approved grants, the benefiting geographical regions covered different parts of the world, including the Chinese Mainland, other Asian regions, Africa and Latin America. Of the programmes approved on the advice of the Committee, most were for the relief of victims of flooding, followed by typhoons/cyclones, earthquakes and droughts.

**Guidelines for grants from the DRF  
(December 2024)  
(Extracted from Guide to Grant Application)**

The guidelines for grants from the DRF are listed as follows:

- (a) Coverage
  - (i) Grants should only be made in cases of a specific disaster<sup>1</sup>, not an on-going problem<sup>2</sup>.
  - (ii) Grants should only be made in cases of disasters of such nature and scale that stimulate a response by the international community.
  - (iii) The relief support should be confined to time-critical response in the emergency context.
- (b) Assessment of Proposals
  - (iv) Grants should be made in response to-
    - I. an appeal made to the international community by a government or a relief organisation for disaster relief aid in the country or locality concerned; or
    - II. an application submitted by a locally registered relief organisation<sup>3</sup> for a disaster relief project being or to be carried out by the organisation. Application for completed relief project is not supported.
  - (v) The appeal/application should be based on humanitarian grounds. Political considerations will not be taken into account.

<sup>1</sup> Including natural disasters and non-natural catastrophes, e.g. explosion of nuclear/chemical facilities and terrorist attacks causing substantial damages and casualties.

<sup>2</sup> Such as refugee problems, wars or post-disaster rehabilitation/reconstruction.

<sup>3</sup> The relief organisation should be a charitable institutions exempted from tax under Section 88 of the Inland Revenue Ordinance, Cap. 112.

- ( vi ) The appeal/application should have received a measure of public support in Hong Kong.
  - ( vii ) Any application by an applicant organisation should outline the nature and scale of the aid project, the number and type of beneficiaries and the size of grant required.
  - ( viii ) The applicant organisation should have demonstrated a sound track record in providing similar types of disaster relief services and activities.
  - ( ix ) The size of the grant should be sufficient to make an impact.
  - ( x ) When there is more than one application of a similar nature and for the same disaster, regard should be given to the anticipated number of beneficiaries, the promptness with which the relief may be provided and the nature of the relief to be provided.
- (c) Conditions of Grant
- ( xi ) Individual grant should take the form of one-off cash payments.
  - ( xii ) The grant should be given to the government concerned or to a reputable relief organisation in the field.
  - ( xiii ) Not more than 5% of the grant may be used to cover overheads or other administrative costs. The rest should be spent entirely on disaster relief services and activities.
  - ( xiv ) The government/applicant organisation concerned is obliged to submit an evaluation report and/or an audited account as appropriate to the Government of the Hong Kong Special Administrative Region on the use of the grant within a specified period.

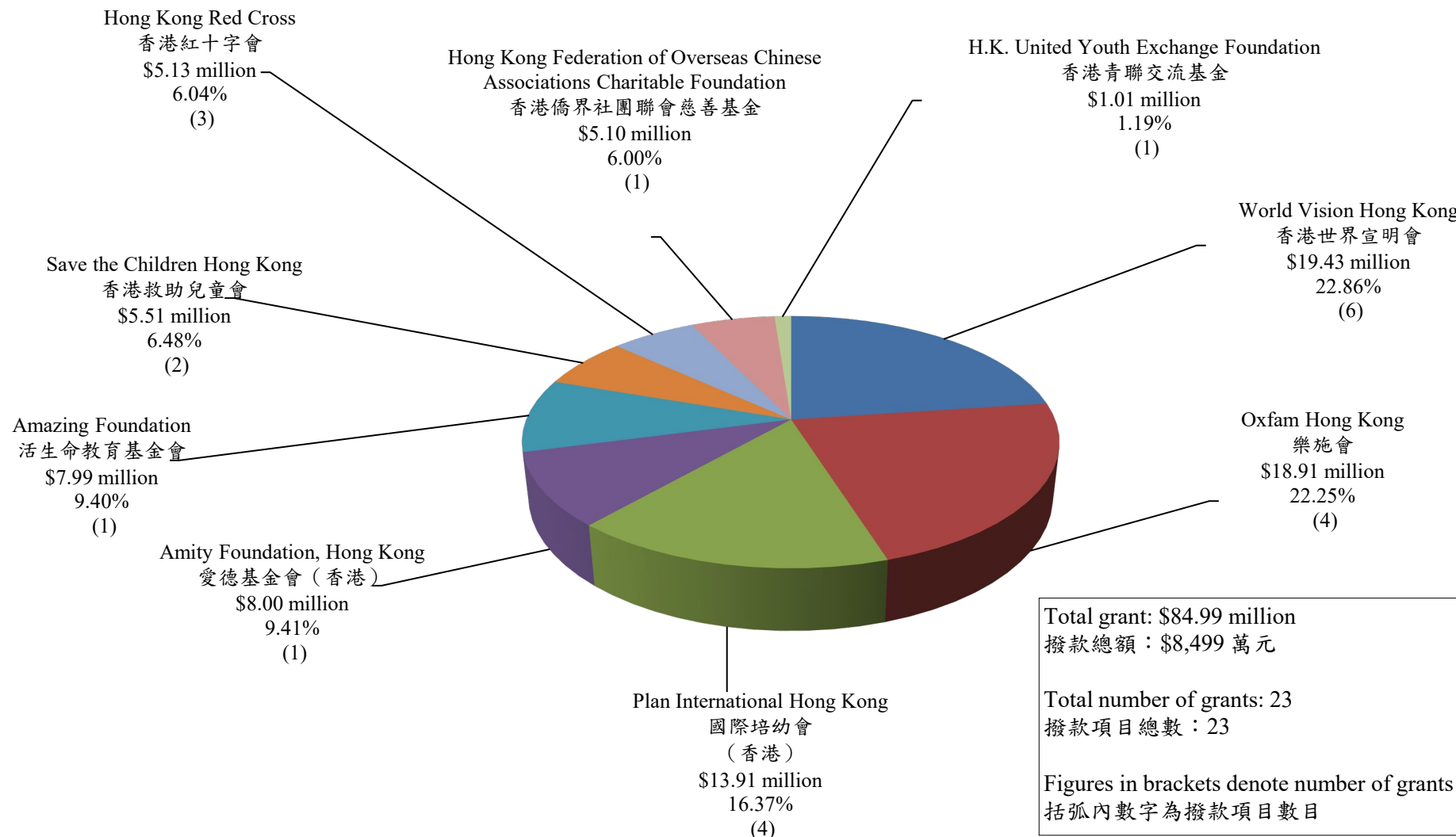

**DISTRIBUTION OF GRANTS ALLOCATED BY RECIPIENTS IN 2024-25**

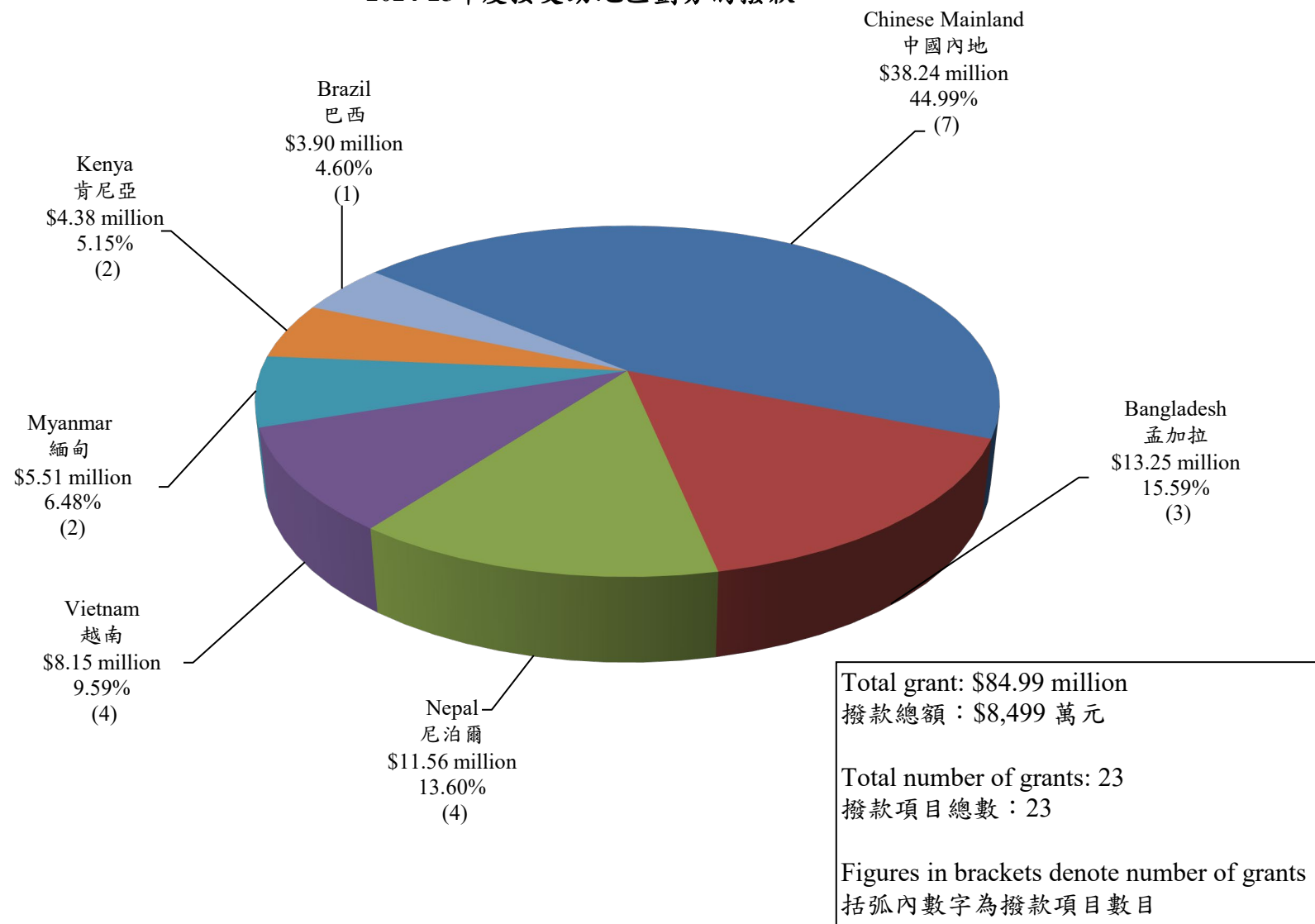

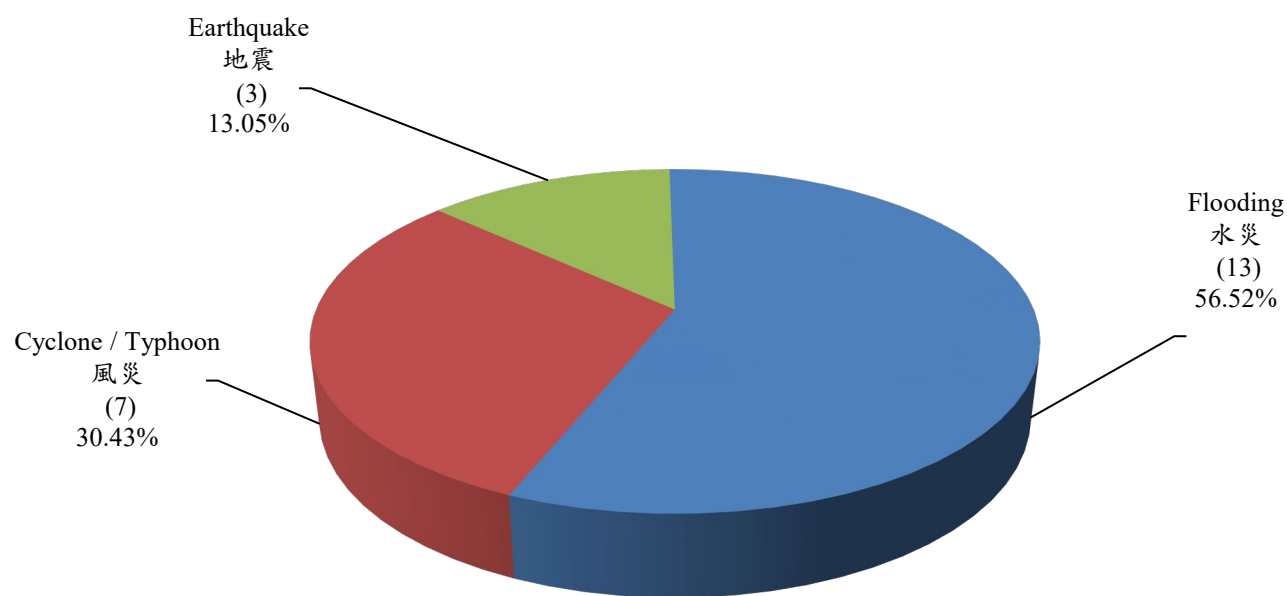

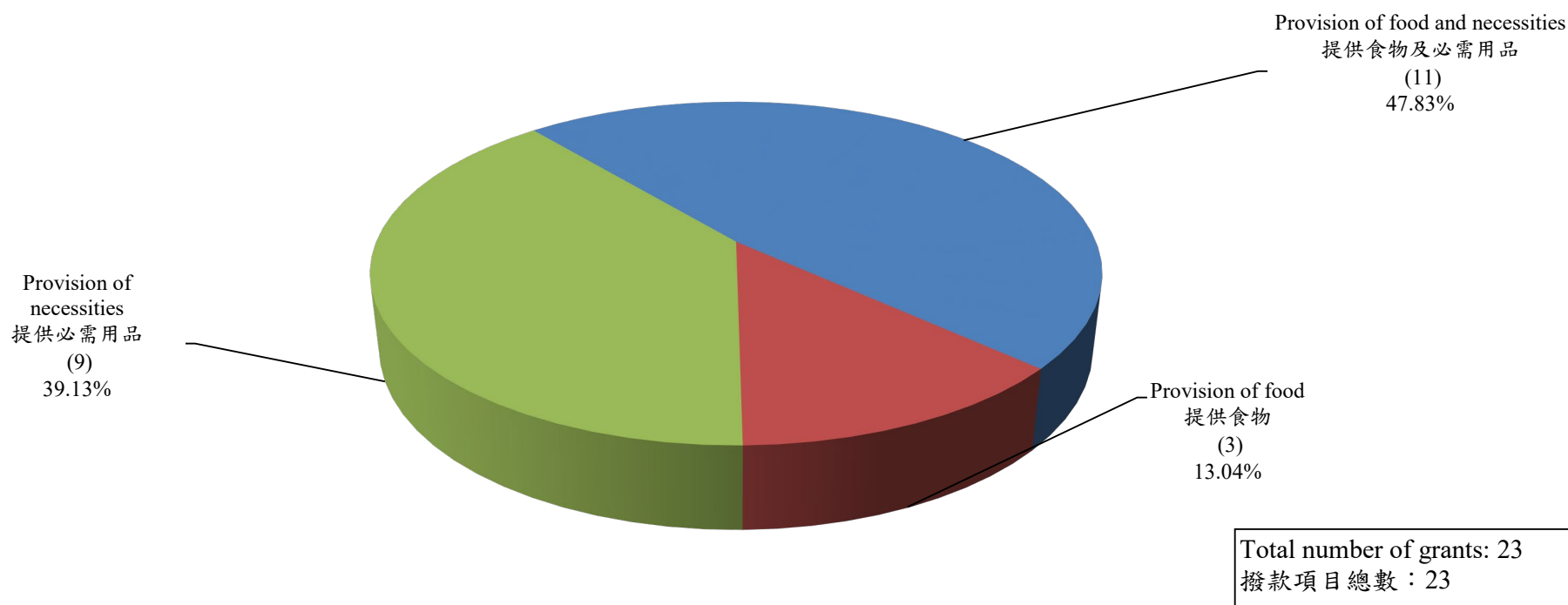
