Report on the Use of a Grant from the Disaster Relief Fund for Emergency Relief to Typhoon Victims in Taiwan

At its meeting on 17 August 2009, the Finance Committee approved a supplementary provision of HK\$50 million to the Disaster Relief Fund (DRF) to provide emergency relief to the victims in Taiwan who were affected by Typhoon Morakot. On the advice of the DRF Advisory Committee, a grant of HK\$50 million was subsequently made to the Taiwanese authorities through the then Chung Hwa Travel Service.

We have received the report. The grant was pooled with other donations designated for the purpose of providing emergency relief to the victims of Typhoon Morakot in Taiwan and their disbursement was managed by an organisation named "財團法人賑災基金會"¹. The total expenditure of their relief efforts amounted to NT\$4,848,435,000² as at 8 August 2010 and the grant

from the HKSAR Government accounted for about 4% of it. The majority of expenditure incurred (over 90%) was to provide financial subsidies/relief supplies to the typhoon victims and contained no administrative overheads. Detailed breakdown of the expenditure is as follows –

The majority of the programmes were completed and people's life has generally resumed normal.
